

LEGAL MAXIM

Meaning: No action arises from an immoral or illegal cause. (A person cannot bring a legal claim if it is based on their own illegal or immoral act.)

Legislative Reference (India): Indian Contract Act, 1872 (Section 23): Agreements opposed to public policy or unlawful are void.

Example: A person enters into a contract with another to smuggle goods. Later, one party refuses to pay the other.

The wronged party goes to court. The court will dismiss the case, stating: "You cannot seek help of law to enforce an illegal agreement." Since the cause itself is unlawful, no action can arise from it.

In Simple Words:

If your claim is based on wrongdoing or illegality, the court will not help you. You cannot sue someone to enforce a contract or agreement that is immoral or against the law.

Why It Matters:

- Keeps the justice system free from supporting or rewarding illegal activities.
- Ensures that people cannot misuse courts to profit from their own wrongdoings.
- Protects the principle of public morality and public policy in law.

"Ex turpi causa non oritur actio"

உதாரணம்: ஒருவர் கடத்தல் செய்வதற்காக ஒப்பந்தம் செய்தால், பின்னர் அந்த ஒப்பந்தத்தின் அடிப்படையில் பணம் கோர முடியாது. ஏனெனில், அந்த ஒப்பந்தம் சட்டவிரோதமானது என்பதால், அதிலிருந்து எந்தவொரு உரிமையும் உருவாகாது.

எளிய விளக்கம்: தவறான செயலில் அடிப்படையிலான கோரிக்கைகளை நீதிமன்றம் ஏற்காது. சட்டவிரோதமான ஒப்பந்தம் அல்லது ஒழுக்கக்கேடான நடவடிக்கையின் மூலம் யாரும் நன்மை பெற முடியாது.

ஏன் இது முக்கியம்?

- சட்டம் எப்போதும் நியாயத்தையும் பொது நலனையும் பாதுகாக்கிறது.
- குற்றச்செயல் அல்லது தவறான ஒப்பந்தத்தை பயன்படுத்தி ஒருவர் லாபம் அடைய முடியாத வகையில் இந்தக் கோட்பாடு செயல்படுகிறது.
- இது சமூக நெறிகளையும் நீதித்துறையின் நேர்மையையும் உறுதிப்படுத்துகிறது.
