

His article critically examines the gaps in implementing the Prevention of Sexual Harassment (POSH) framework within political institutions, reflecting on systemic challenges, gendered power structures, and the urgent need for accountability. This achievement highlights VMLS's strong research culture and commitment to advancing meaningful scholarship at the intersections of law, governance, and social justice. The publication stands as an inspiration for students and scholars pursuing impactful, policy-relevant research.

## LEGAL MAXIM

**Meaning:** Agreements must be kept (It means that states are legally bound to honor the treaties they sign, and must perform their obligations in good faith.)

#### Legislative / Treaty Reference (International Law):

Vienna Convention on the Law of Treaties, 1969

**Article 26:** "Every treaty in force is binding upon the parties to it and must be performed by them in good faith."

**Principle of Good Faith:** This maxim rests on the foundational rule that nations must comply honestly and faithfully with their international obligations.

**Example:** If Country A signs a treaty promising not to test nuclear weapons,

but later conducts secret nuclear tests, it violates "Pacta Sunt Servanda"

Such a breach can lead to diplomatic protests, sanctions, or retaliation in international forums.

**In Simple Words:** When countries sign a treaty, they must do what they promised. They cannot ignore, deny, or break obligations simply because it becomes inconvenient later.

#### Why It Matters:

- · Maintains trust and stability among nations.
- Ensures predictability in international relations.
- Protects the legitimacy of treaties.
- Forms the backbone of all international agreements.

#### "Pacta Sunt Servanda"

பொருள்: ஒப்பந்தங்கள் பூரணமாகக் கடைப்பிடிக்கப்பட வேண்டும் (சர்வதேச ஒப்பந்தங்களில் கையெழுத்திட்ட நாடுகள், அந்த ஒப்பந்தத்தின் கடமைகளை நேர்மையாகவும் நம்பிக்கையுடனும் செயல்படுத்த வேண்டும்.)

சர்வதேச சட்ட குறிப்புகள்: வியன்னா உடன்படிக்கை சட்டம், 1969

பிரிவு 26: "செயல்பாட்டில் உள்ள ஒவ்வொரு உடன்படிக்கையும், அதில் பங்கேற்கும் நாடுகளுக்கு கட்டாயமானது; அவர்கள் அதை நம்பகத்தன்மையுடனும் நல்லநம்பிக்கையுடனும் செயல்படுத்த வேண்டும்."

நல்லநம்பிக்கை (Good Faith) கோட்பாடு : நாடுகள் தங்கள் சர்வதேச கடமைகளை நேர்மையாக பின்பற்ற வேண்டும் என்பதன் அடிப்படையில் இந்த சட்டச் சொற்றொடர் அமைந்துள்ளது.

உதாரணம்: ஒரு நாடு அணு ஆயுத சோதனையை நடத்தமாட்டோம் என்று ஒப்பந்தத்தில் கையெழுத்திடுகிறது. ஆனால் பின்னர் ரகசியமாக அணு சோதனைகள் நடத்துகிறது. இது "Pacta Sunt Servanda" என்ற கோட்பாட்டை மீறுவது. இதன் விளைவாக சர்வதேச எதிர்ப்பு, தடை, அல்லது அரசியல் நடவடிக்கைகள் ஏற்படலாம்.

**எளிய சொற்களில்** : ஒரு நாடு ஒரு சர்வதேச ஒப்பந்தத்தில் கையெழுத்திட்டால், அது வாக்குறுதி செய்ததை கட்டாயமாக பின்பற்ற வேண்டும். பின்னர் வசதிக்கேற்ப அதை மறுப்பதோ, மீறுவதோ செய்ய இயலாது.
