

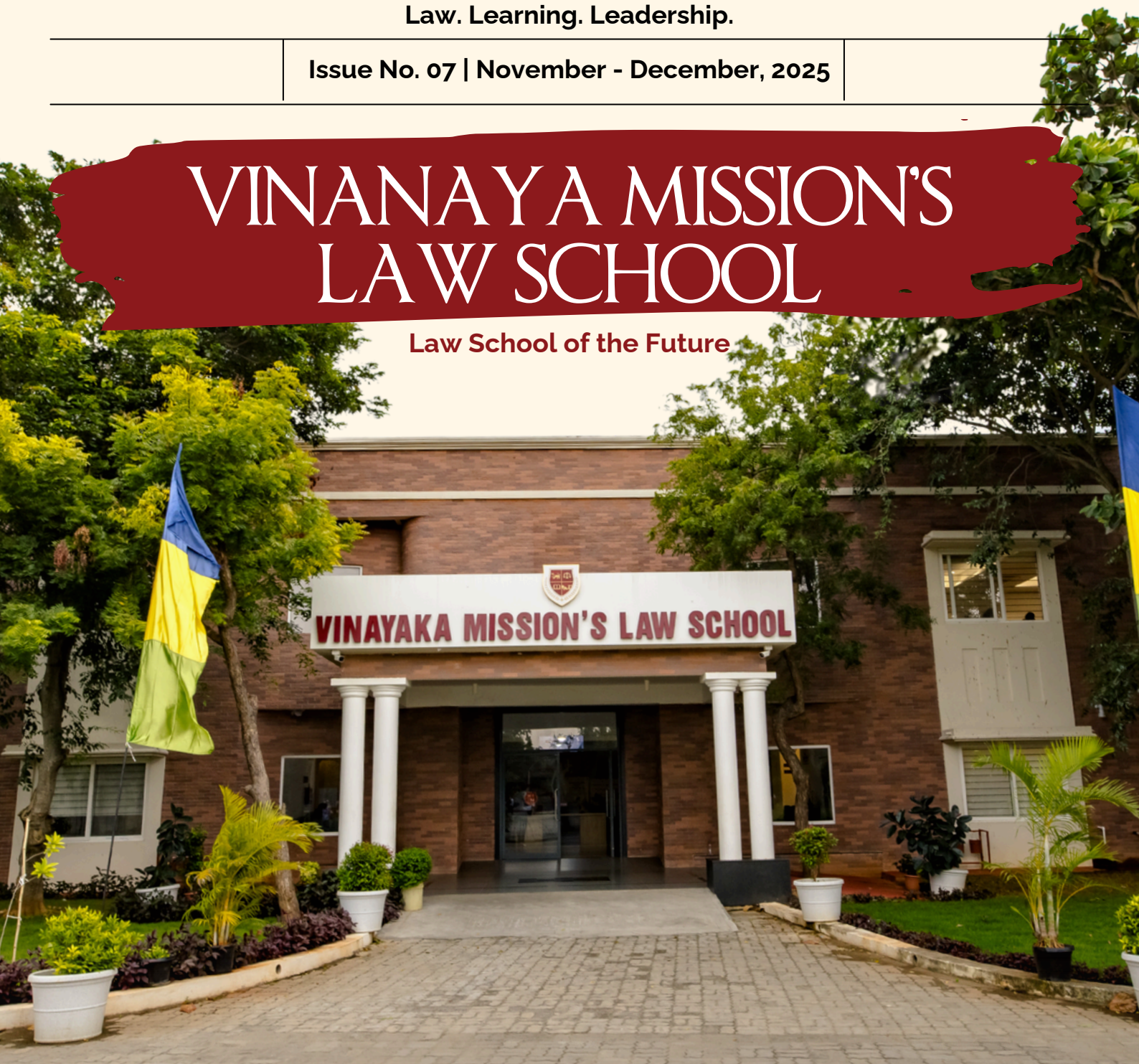

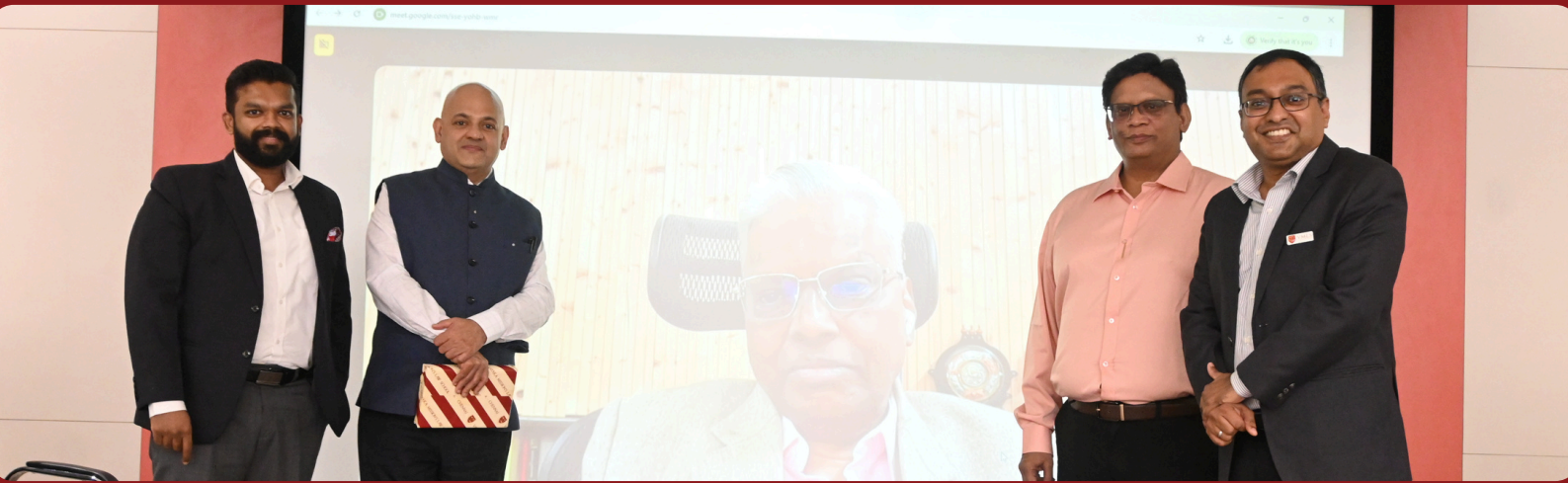

November 26, 2025 | VMLS Campus

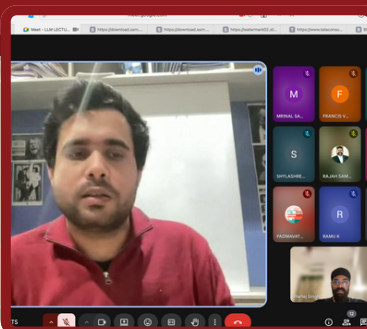

LEGAL MAXIM

Meaning: Peremptory norms of international law
(These are fundamental principles that no state can violate, even by treaty.)

Legislative / Treaty Reference (International Law):

Vienna Convention on the Law of Treaties (1969)

Article 26: A treaty is void if it conflicts with a jus cogens norm.

These norms include:

- Prohibition of genocide
- Prohibition of slavery
- Prohibition of torture
- Basic principles of humanitarian law

Example: Countries cannot sign a treaty allowing slavery. Even if they do, the treaty is automatically void because it violates jus cogens.

In Simple Words: Some rules in international law are so important that no country can break them — ever.

Why It Matters:

- Protects fundamental human rights
- Ensures minimum standards of humanity
- Limits state power
- Forms the highest level of legal norms worldwide
