

Addressing a distinguished audience of advocates, Dr. Ananth presented an engaging lecture on "Copyright Law in the Age of Al and Machine

He explored two interlinked aspects of copyright law in the AI era - authorship and infringement. The first centered on whether AI-generated works can qualify for copyright protection and if prompt engineering may allow users to claim authorship. The second examined whether generative AI models that utilize copyrighted material for training commit infringement and if legislative clarity is needed to balance innovation and creative rights.

Dr. Ananth emphasized that while human authorship remains the cornerstone of copyright protection, evolving global perspectives-ranging from China's recognition of prompt engineers to the U.S.'s human-centric approach-reflect diverse interpretations. His lecture concluded with a lively discussion among advocates, followed by a felicitation by members of the Madras High Court. The session captured VMLS's ongoing pursuit of thought leadership at the intersection of law, technology, and contemporary practice.

#### Guest Lecture by Prof. (Dr.) M. Sakthivel

Sakthivel, Professor and Dean (Research) at Tamil Nadu National Law University, on "Library Exceptions under the Indian Copyright Act: An Analysis of the Sci-Hub Case." Dr. Sakthivel traced the evolution of library rights from Ranganathan's Five Laws of Library Science to the contemporary copyright framework, examining statutory exceptions under Sections 52 and 65A of the Copyright Act, 1957. He discussed issues of reproduction, preservation, and accessibility for persons with disabilities, while addressing emerging challenges of the digital era such as controlled digital lending and subscription-based publishing. Through the Sci-Hub case, he explored the tension between research access and intellectual property, prompting critical reflection on how copyright law can balance innovation with the public interest in knowledge dissemination.

# LEGAL MAXIM

#### Meaning:

Meeting of minds (It means that all parties to an agreement must understand and agree to the same thing in the same sense.)

#### Legislative Reference (India):

Indian Contract Act, 1872 (Section 13): "Two or more persons are said to consent when they agree upon the same thing in the same sense."

#### Section 10:

An agreement becomes a contract only when there is free consent between competent parties.

#### Example:

A agrees to sell his car to B.

B believes he is purchasing A's bike.

Since A and B are not agreeing on the same subject matter, there is no true meeting of minds (no consensus ad idem).

Therefore, no valid contract is formed.

#### In Simple Words:

A contract is valid only when both parties clearly understand and agree to the same thing. If there is confusion, mistake, or misunderstanding about what is being agreed upon, there is no real consent, and the agreement cannot be enforced.

#### Why It Matters:

- Ensures clarity and transparency in agreements.
- Prevents disputes arising from misunderstanding miscommunication.
- Protects the integrity and fairness of contractual relationships.
- Forms the foundation of all valid and enforceable contracts.

### "Consensus ad idem"

#### பொருள்:

ஒரே பொருளில் ஒரே எண்ணம் (ஒரு ஒப்பந்தம் செல்லத்தக்கதாக இருக்க, அதில் ஈடுபடும் இரு தரப்பும் ஒரே பொருளை ஒரே பொருளில், ஒரே எண்ணத்தில் புரிந்து அதற்கே சம்மதிக்க வேண்டும்.)

## இந்திய சட்டம்:

இந்திய ஒப்பந்தச் சட்டம், 1872 (பிரிவு 13): "இருவர் அல்லது அதற்கு மேற்பட்டோர் ஒரே பொருளில் ஒரே எண்ணத்தில் ஒப்புக்கொண்டால், அது சம்மதம் எனப்படுகிறது."

#### பிரிவு 10:

ஒரு ஒப்பந்தம் செல்லத்தக்கதாக இருக்க, தரப்புகளுக்கிடையில் சுதந்திரமான மற்றும் தெளிவான சம்மதம் இருக்க வேண்டும்.

#### உதாரணம்:

A தனது நால்சக்கர வாகனத்தை விற்க சம்மதிக்கிறார்.

ஆனால் B. A தனது இருசக்கர வாகனத்தை விற்கிறார் என்று நினைக்கிறார். இருவரும் ஒரே பொருளில் ஒரே எண்ணத்தில் இல்லை. எனவே, Consensus ad Idem இல்லை — அதாவது செல்லத்தக்க ஒப்பந்தம் உருவாகாது.

#### எளிய சொற்களில்:

ஒரு ஒப்பந்தம் செல்ல, இரு தரப்பும் அதே பொருளை ஒரே விதமாக புரிந்து, அதற்கே சம்மதிக்க வேண்டும். பொருளில் குழப்பம், தவறான புரிதல் அல்லது எண்ண வேறுபாடு இருந்தால், அந்த ஒப்பந்தம் செல்லாது.

#### ஏன் இது முக்கியம்?

- ஒப்பந்தத்தில் இரு தரப்பும் உண்மையான புரிதலுடன் இருப்பதை உறுதி செய்கிறது.
- தவறான புரிதல் அல்லது குழப்பத்தால் ஏற்படும் தகராறுகளைத் தடுக்கிறது.
- ஒப்பந்த உறவுகளில் வெளிப்படைத்தன்மை மற்றும் நியாயத்தை நிலைநாட்டுகிறது.
- இது ஒப்பந்தச் சட்டத்தின் முக்கியமான அடிப்படை கோட்பாடுகளில் ஒன்று
